

Attempt to Appeal the Results of UAW Local Union 600

Dearborn Truck Plant Ratification Vote via Alleged EPC Infractions

Dear Brother Pedersen:

Please be advised that your letter of appeal, postmarked December 11, 2015, has been received by this office. However, after further review of the case file relatable to clarification provided by your local union, it has been determined that your attempt to appeal to this office is premature. Article 32, Section 5(a) of the UAW International Constitution, Public Review Board: UAW Ethical Practices Codes (EPC), indicates the constitutional construct when alleging violations of the EPC. It reads, in pertinent part:

"If a complaint is against the operation of a subordinate body or any officer or representative thereof, the complaint must be initiated by a member of that subordinate body who shall be obligated to first attempt to seek redress and corrective action of the matter complained of through appeal to the membership of the Local Union . . ."

However, the record reflects that you made an initial effort to appeal to the local union, on or about December 7, 2015. Contrarily, and pursuant to the aforesaid constitutional article, your initial appeal should have been presented first at a meeting of the membership body of your unit, or in writing addressed to the Recording Secretary or Chairperson of that unit. An appeal from that unit is then duly made to the Local Union's Delegate Body and/or General Council.

Notwithstanding the foregoing, it would provide no constructive value to remand your appeal to the unit at this interval. Be that as it may, in response to your attempted appeal to the local union, you were provided with the following response from Local Union 600 Recording Secretary David Freeman. This communication, dated December 21, 2015, reads as follows:
