

# Letters from around the world denounce Democrats' effort to bar SEP candidate from Illinois ballot

*The following letters were sent to the Mark Shelden, the County Clerk in Champaign, Illinois, to protest the efforts of the state and local Democratic Party to exclude the Socialist Equality Party and its state legislative candidate, Thomas Mackaman, from the ballot in the November elections.
