

# Letters denounce Democrats' effort to bar SEP candidate from Illinois ballot

*The following letters were sent to Mark Shelden, the County Clerk in Champaign, Illinois, to protest the efforts of the state and local Democratic Party to exclude the Socialist Equality Party and its state legislative candidate, Thomas Mackaman, from the ballot in the November elections. Dear Mr. Shelden:

I wish to register my anger and outrage at the attempt by members of the Democratic Party of Illinois to deny the candidate of the Socialist Equality Party a place on the November ballot. As someone who believes in democracy and the unrestricted right of political parties to ballot access, this effort is shameful and deserves to be scorned by all those who express similar beliefs.

It is bad enough that, in a country that consistently portrays itself as the paragon of "freedom," it is especially difficult for "third" parties—most notably parties seeking to give voice to the interests of working people—to participate in what is the cornerstone of "freedom": the electoral process. Thus, it is especially disgusting that one of the two established political parties would engage in a systematic campaign to deny ballot access to others.

It is clear, should you be inclined to question it, that this is a conscious, systematic campaign. As anyone who has been following the course of the 2004 presidential election is aware, state Democratic parties across the country have been engaged in efforts to sabotage ballot-access drives, to deny independent and "third"-party candidates places on the ballot, and to further restrict who can appear on that ballot.

The legal challenge by the state Democratic Party to Ralph Nader's independent campaign in Arizona is not an isolated incident. Neither is the recent action of Democratic Party activists in Oregon, who packed a nominating convention in order to deny him access to that state's ballot. In fact, it is becoming clear that these anti-democratic actions are being encouraged by the Democratic National Committee, the body responsible for the daily activities of the party.

The *New York Times* of June 30 quoted a spokesperson of the DNC, who bluntly stated that "we support these efforts" to restrict access to the ballot for independents and "third" parties.

I have seen these efforts myself, here in Michigan. The party to which I belong was engaged in a difficult ballot-access drive. On a number of occasions, members of the Michigan Democratic Party—including local and state elected officials—sought to challenge and obstruct our right to collect signatures. On one occasion, a representative for a Democratic county clerk threatened to "unenroll" our members from the voter rolls, which would have invalidated the petitions they circulated.

These actions fly in the face of the very name by which these people identify themselves. They represent the heights of autocratic, even dictatorial, functioning. There is certainly no way they can be seen as anything consistent with the principles of democracy. Indeed, one of the main reasons why people abstain from voting is because other political parties are denied equal access to the electoral process (in violation of the XIV Amendment of the Constitution, in my opinion), and thus they feel there is no reason to make the effort to go to the polls, since neither party represents their viewpoint or interests.

Even though I have a number of differences with the political platform of the Socialist Equality Party, I will unconditionally defend their right to present their viewpoint and platform to the voters of this country. To this end, I wish to add my voice to those who have already registered their objection to these patently anti-democratic actions.

I patiently look forward to your decision on this matter, and I appreciate your attention to this matter.

Dear Mr. Shelden:

I am a resident of North Carolina, an English graduate student, and an unaffiliated reader of the *World Socialist Web Site*. It has recently come to my attention from recent editorial statements on the web site that Democratic Party officials in Champaign County, Illinois, have contested Socialist Equality Party (SEP) candidate Thomas Mackaman’s running for a seat in the 103rd District of the Illinois House of Representatives, and that the Champaign County Election Board has acquiesced to these disputable objections. Although I reside outside your jurisdiction, I hope this shall not invalidate the principled concerns I wish to bring to the important office you hold as Champaign County Clerk.

As a dedicated and free-thinking American citizen, I believe that the aforesaid action by the Democratic Party is a general violation of the rights of third parties in the United States and a particular violation of the rights of those 2,032 people who signed the petition to place Mr. Mackaman on the ballot in the first place. The behavior is unpardonable precisely because one of the two major parties of big business is clearly *manipulating* and *forcing* potential SEP voters to either select a candidate who does not represent their interests or to abstain from the upcoming November elections altogether. I do not believe these are democratic alternatives nor do I believe this is what America stands for. The signatures are a declaration of a loss of faith in the Democratic and Republican parties. This is a thoroughly serious affair which cannot and should not be ignored, but acknowledged and respected in a manner befitting civil society.

No party under a democratic system of government should have the privilege of abusing its influence to the extent that it dictates the actions of a free citizenry. For such departs from government of the people, by the people, and for the people, mutating instead into something more heinous, repugnant, and tyrannical: government above, against, and over the people. Nothing could be more antithetical to the ideals and political freedoms of our civic culture, contradictory as the social realities of America may be. The opening page of your Champaign County Clerk website (<http://www.champaigncountyclerk.com>) states the following:

Participating in democracy and elections are some of the best ways to improve our communities. As these words suggest, elections are not only about votes. Elections are an objective expression of real social concerns, issues, and needs. If a people cannot elect its representatives without hindrance, then how can democracy flourish and the popular will be satisfied? In short, I see no defensible reason for denying Mr. Mackaman and his supporters the liberties to which they are entitled.

With the above in mind, I appeal to your wisdom in the interest of the democratic rights of third parties in the United States and the masses of American working people and youth who constitute the majority of the voting public, and kindly ask you to overturn the Democratic Party objection and permit Mr. Mackaman of the SEP to campaign as an independent antiwar socialist candidate. Unless intelligent and prudent measures are taken, democracy and the signatures of those 2,032 individuals who petitioned for his ballot status will be in vain. Thank you for your time and consideration in this urgent and historically significant matter.
