## Letters continue to condemn Democrats' effort to bar SEP candidate from Illinois ballot

Dear Mr. Shelden,

As a fellow citizen and concerned voter, I must bring to your immediate attention my vehement opposition to the Democratic Party's recent undemocratic and hypocritical challenge to Tom Mackaman's 2,032 signatures for ballot status as an independent candidate for the 103rd District of the Illinois House of Representatives.

It is a well-established fact that throughout our nation, including the states of Illinois and California, the Democratic and Republican parties consistently engage in legalistic battles to prevent the American people from hearing opposing political platforms and issues.
