

# Sri Lankan SEP gains support for campaign against pro-government thuggery

The Socialist Equality Party (SEP) in Sri Lanka is gaining support from workers, youth and academics throughout the world for its campaign against pro-government thugs' violent attack on its members at Moratuwa University.

Dehin Wasantha and Lakshman Fernando were physically assaulted near the rear gate of the university on November 30 by Indika Perera and Suranga Piyawardena—the president and secretary of the Moratuwa university branch of Podujana Pragathishili Sevaka Sangamaya (PPSS). The trade union is affiliated to the country's ruling party—the Sri Lankan Podujana Peramuna.

Wasantha, a university non-academic worker for more than two decades, is well-known for his principled struggle for rights of his fellow workers and the working class as a whole and socialism. Fernando is a full-time party worker.

They were violently attacked with long wooden clubs causing serious injuries while campaigning with other party members near the rear gate of the university for SEP public meetings on the Centenary of Trotskyism addressed by Joseph Kishore, National Secretary of the SEP (US).

Wasantha suffered two fractured fingers and had to go on medical leave for almost a month, as his fingers took a considerable period to mend. Lakshman was badly bruised and left with a neck injury.

When the case on the violent attack was brought before a judge at the Magistrate's Court in Moratuwa on January 8, the Magistrate ordered the case to be referred to a mandatory Mediation Board. The case will be recalled at the court on May 20.

As Perera and Piyawardena were not present when the Mediation Board took the case on January 20, the board decided to reconvene the case on February 3.

They were present at the board's hearing on February 3 and opted for a settlement. Wasantha categorically stated that he would not accept a settlement. Then the board asked both parties to be present at the courts on May 20.

In response to the campaign launched by the SEP and its sister parties of the International Committee of the Fourth International (ICFI) in defence of Wasantha and Fernando and the SEP's democratic rights, workers, youths, academics and their organisations around the world have sent protest letters to relevant Sri Lankan authorities condemning the attack and demanding the culprits be prosecuted to the full extent of the law.

We are publishing here some protest letters sent from US and Sri Lanka.

## **Robert B. Livingston, San Francisco, US:**

Dear Senior Professor N.D. Gunawardena, Vice Chancellor, University of Moratuwa and Attorney General Sanjay Rajaratnam,

My name is Robert B. Livingston. I live and work in San Francisco in California.

I write to you today to register my agreement with a very principled American, Will Lehman who is protesting the lawless injury of two Sri Lankan Socialist Equality Party members by union thugs.

I was shocked when I read about it at the *World Socialist Web Site*, the most read socialist news on the internet.

With Mr. Lehman, I implore you to hold the thugs, Indika Perera and Suranga Piyawardena to full account for their crimes against civil society.

I myself have encountered such evil brutes while picketing on behalf of hotel workers here in San Francisco. Some of the hotel workers were Sri Lankan immigrants here.
